ANNOUNCEMENT OF OFFER PRICE AND ALLOTMENT

SUMMARY

Offer Price

- The final Offer Price has been determined at HK\$0.40 per Offer Share (excluding brokerage of 1%, the SFC transaction levy of 0.0027% and the Stock Exchange trading fee of 0.005%).

Net Proceeds from the Global Offering

- Based on the final Offer Price of HK\$0.40 per Offer Share, the net proceeds from the Global Offering to be received by the Company, after deduction of underwriting fees and commission, and other estimated expenses payable by the Company in connection with the Global Offering and assuming the Over-allotment Option is not exercised, are estimated to be approximately HK\$70.4 million. The Company intends to use the net proceeds from the Global Offering in the manner as set out in the paragraph headed “Net Proceeds from the Global Offering” in this announcement.
- If the Over-allotment Option is exercised in full, the Company will receive additional net proceeds of approximately HK\$20.6 million for 51,375,000 Shares to be issued upon the exercise of the Over-allotment Option. The additional amount raised will be applied to the purposes of use of proceeds in the proportions set out in the Prospectus.

Applications under the Hong Kong Public Offering

- The Hong Kong Offer Shares initially offered under the Hong Kong Public Offering have been very significantly over-subscribed. A total of 138,113 valid applications have been received pursuant to the Hong Kong Public Offering on (i) **WHITE** and **YELLOW** Application Forms, (ii) through giving **electronic application instructions** to HKSCC via CCASS, and (iii) to the **HK eIPO White Form** Service Provider under the **HK eIPO White Form** service for a total of 13,218,870,000 Hong Kong Offer Shares, representing approximately 386.0 times of the total number of 34,250,000 Hong Kong Offer Shares initially available for subscription under the Hong Kong Public Offering.
- As the over-subscription in the Hong Kong Public Offering represents 100 times or more the total number of Offer Shares initially available under the Hong Kong Public Offering, the re-allocation procedure as disclosed in the section headed “Structure of the Global Offering — Hong Kong Public Offering — Re-allocation” in the Prospectus has been applied and 137,000,000 Offer Shares have been re-allocated from the International Placing to the Hong Kong Public Offering. The final number of Offer Shares under the Hong Kong Public Offering is 171,250,000 Offer Shares, representing 50% of the total number of Offer Shares initially available under the Global Offering (before any exercise of the Over-allotment Option), and being allocated to 8,710 successful applicants under the Hong Kong Public Offering.

International Placing

- The Offer Shares initially offered under the International Placing have been just sufficiently subscribed, and an over-allocation of 51,370,000 Shares was made in the International Placing. A total of 342,915,000 International Placing Shares (including the subscription amount of the Cornerstone Investors) have been subscribed, represented approximately 1.1 times of the total number of 308,250,000 International Placing Shares initially available for subscription under the International Placing. After re-allocation of the Offer Shares to the Hong Kong Public Offering from the International Placing, the final number of Offer Shares under the International Placing is 171,250,000 Shares, representing 50% of the total number of the Offer Shares initially available under the Global Offering (before any exercise of the Over-allotment Option). There has been an over-allocation of 51,370,000 Offer Shares and there are a total of 149 places under the International Placing. A total number of 31 places have been allotted 5 board lots of Shares or less, representing approximately 20.81% of total number of places under the International Placing. These places have been allotted approximately 0.43% of the 222,620,000 Offer Shares available under the International Placing after reallocation and approximately 0.24% of the Offer Shares under the Global Offering inclusive of the over-allocation of 51,370,000 Shares. A total number of 29 places have been allotted 4 board lots of Shares or less, representing approximately 19.46% of total number of places under the International Placing. These places have been allotted approximately 0.39% of the 222,620,000 Offer Shares available under the International Placing after reallocation and approximately 0.22% of the Offer Shares under the Global Offering inclusive of the over-allocation of 51,370,000 Shares. A total number of 27 places have been allotted 3 board lots of Shares or less, representing approximately 18.12% of total number of places under the International Placing. These places have been allotted approximately 0.35% of the 222,620,000 Offer Shares available under the International Placing after reallocation and approximately 0.20% of the Offer Shares under the Global Offering inclusive of the over-allocation of 51,370,000 Shares. A total number of two places have been allotted 2 board lots of Shares or less, representing approximately 1.34% of total number of places under the International Placing. These places have been allotted approximately 0.01% of the 222,620,000 Offer Shares available under the International Placing after reallocation and approximately 0.01% of the Offer Shares under the Global Offering inclusive of the over-allocation of 51,370,000 Shares. One placee has been allotted one board lot of Shares, representing approximately 0.67% of total number of places under the International Placing. This placee has been allotted less than 0.01% of the 222,620,000 Offer Shares available under the International Placing after reallocation and less than 0.01% of the Offer Shares under the Global Offering inclusive of the over-allocation of 51,370,000 Shares.

Cornerstone Investors

- Based on the final Offer Price of HK\$0.40 per Offer Share (exclusive of brokerage of 1.0%, SFC transaction levy of 0.0027% and Stock Exchange trading fee of 0.005%) and pursuant to the Cornerstone Investment Agreements with the Cornerstone Investors, the number of Offer Shares subscribed for by the Cornerstone Investors has now been determined. Haohai Healthcare has subscribed for 50,000,000 Offer Shares, and Tu Yi HK has subscribed for 25,000,000 Offer Shares, representing approximately (i) 14.6% and 7.3% of the Offer Shares initially available under the Global Offering, respectively; and (ii) 2.4% and 1.2% of the total issued share capital of the Company, respectively, immediately following the completion of the Global Offering (in each case, assuming that the Over-allotment Option is not exercised and without taking into account any Shares which may be issued upon exercise of any options which may be granted under the Share Option Scheme). Please refer to the paragraph headed “Cornerstone Investors” in this announcement for further details relating to the Cornerstone Investors.

Compliance with Placing Guidelines

- None of the Sole Sponsor, the Joint Global Coordinators, the Joint Bookrunners, the Joint Lead Managers, the Underwriters or their respective affiliates, companies and connected clients of the lead broker or of any distributors (as defined in Appendix 6 to the Listing Rules) has been placed with any Offer Shares for its own benefit under the Global Offering. The Directors confirm that, no Offer Shares under the International Placing have been allocated to placees who are Directors, existing shareholders of the Company or beneficial owners of Shares and/or any securities of the Company's subsidiaries or their respective close associates and core connected persons of the Company within the meaning of the Listing Rules, whether in their own names or through nominees, and that all placees and the public who has subscribed for the Offer Shares and their beneficial owners are independent of and not connected with the Company. The Directors further confirm that the International Placing has been conducted in compliance with the placing guidelines for equity securities as set out in Appendix 6 to the Listing Rules (the "**Placing Guidelines**") and no Offer Shares placed by or through the Joint Global Coordinators, the Joint Bookrunners, the Joint Lead Managers and the Underwriters under the Global Offering have been placed with any core connected person (as such term is defined in the Listing Rules) of the Company or any connected clients (as defined in paragraph 5(1) of the Placing Guidelines) or persons set out in paragraph 5 of the Placing Guidelines, whether in their own names or through nominees. None of the Offer Shares subscribed by the placees or the public has been financed directly or indirectly by any of the Directors, chief executive of the Company, Controlling Shareholders, substantial Shareholders, or existing shareholders of the Company or any of its subsidiaries or their respective close associates, and none of the placees or the public who has subscribed the Offer Shares is accustomed to taking instructions from any of the Directors, chief executive of the Company, Controlling Shareholders, substantial Shareholders or existing shareholders of the Company or any of its subsidiaries or their respective close associates in relation to the acquisition, disposal, voting or other disposition of Shares registered in his/her/its name or otherwise held by him/her/it. No placee will, individually, be placed with more than 10% of the enlarged issued share capital of the Company immediately after the Global Offering. Over-allotment Option

There has been an over-allocation of 51,370,000 Shares in the International Placing and such over-allocation will be settled using Shares to be borrowed under the Stock Borrowing Agreement between Ruide BVI and the Stabilising Manager. Such borrowed Shares will be covered by exercising the Over-allotment Option in full or in part or by making purchases by the Stabilising Manager (or through its affiliates or any person acting for it) in the secondary market at prices that do not exceed the final Offer Price, or by a combination of these means. NET PROCEEDS FROM THE GLOBAL OFFERING

Based on the final Offer Price of HK\$0.40 per Offer Share, the net proceeds from the Global Offering to be received by the Company, after deducting the underwriting fees and commissions and other estimated expenses payable by the Company in relation to the Global Offering and assuming the Over-allotment Option is not exercised, are estimated to be approximately HK\$70.4 million. The Company currently intends to apply such net proceeds in accordance with the purposes set out in the section headed “Future Plans and Use of Proceeds” in the Prospectus, as follows:

- approximately HK\$19.7 million (equivalent to approximately 28.0% of our total estimated net proceeds) will be used for renovating all our existing aesthetic medical institutions and expand our Hangzhou Raily, Raily Tiange and Wuhu Raily, in order to increase capacity, refresh our brand image and expand our market share;
- approximately HK\$19.7 million (equivalent to approximately 28.0% of our total estimated net proceeds) will be used for funding the capital expenditure and initial operating costs for establishing our new aesthetic medical institution in Shanghai City;
- approximately HK\$10.6 million (equivalent to approximately 15.0% of our total estimated net proceeds) will be used for potential strategic acquisition of aesthetic medical institutions in Zhejiang Province in the PRC;
- approximately HK\$7.8 million (equivalent to approximately 11.0% of our total estimated net proceeds) will be used for the purchase of aesthetic medical service equipment and medical consumables to improve certain aesthetic medical procedures and to extend the spectrum of our aesthetic medical service;
- approximately HK\$5.6 million (equivalent to approximately 8.0% of our total estimated net proceeds) will be used for active promotion of our brand; and
- approximately HK\$7.0 million (equivalent to approximately 10.0% of our total estimated net proceeds) for our working capital and other general corporate purposes.

- 234 valid applications for a total of 3,597,280,000 Shares were for Hong Kong Offer Shares with an aggregate subscription amount based on the maximum Offer Price of HK\$0.40 per Offer Share (excluding brokerage of 1.0%, SFC transaction levy of 0.0027% and Stock Exchange trading fee of 0.005%) of more than HK\$5 million (equivalent to approximately 210.1 times of the 17,120,000 Shares initially available for allocation in pool B of the Hong Kong Public Offering).

One application has been rejected due to bounced cheques. No invalid applications have been identified for not having been completed in accordance with the instructions on the Application Forms. 300 multiple applications or suspected multiple applications have been identified and rejected. No application for more than 17,120,000 Hong Kong Offer Shares has been identified.

As the over-subscription in the Hong Kong Public Offering represents 100 times or more the total number of Offer Shares initially available under the Hong Kong Public Offering, the re-allocation procedure as disclosed in the section headed “Structure of the Global Offering — Hong Kong Public Offering — Re-allocation” in the Prospectus has been applied and 137,000,000 Offer Shares have been re-allocated from the International Placing to the Hong Kong Public Offering. The final number of Offer Shares under the Hong Kong Public Offering is 171,250,000 Offer Shares, representing 50% of the total number of Offer Shares initially available under the Global Offering (before any exercise of the Over-allotment Option), and being allocated to 8,710 successful applicants under the Hong Kong Public Offering.

The Offer Shares offered in the Hong Kong Public Offering were conditionally allocated on the basis set forth in the paragraph “Basis of Allotment under the Hong Kong Public Offering” below in this announcement.

INTERNATIONAL PLACING

These places have been allotted approximately 0.39% of the 222,620,000 Offer Shares available under the International Placing after reallocation and approximately 0.22% of the Offer Shares under the Global Offering inclusive of the over-allocation of 51,370,000 Shares. A total number of 27 places have been allotted 3 board lots of Shares or less, representing approximately 18.12% of total number of places under the International Placing. These places have been allotted approximately 0.35% of the 222,620,000 Offer Shares available under the International Placing after reallocation and approximately 0.20% of the Offer Shares under the Global Offering inclusive of the over-allocation of 51,370,000 Shares. A total number of two places have been allotted 2 board lots of Shares or less, representing approximately 1.34% of total number of places under the International Placing. These places have been allotted approximately 0.01% of the 222,620,000 Offer Shares available under the International Placing after reallocation and approximately 0.01% of the Offer Shares under the Global Offering inclusive of the over-allocation of 51,370,000 Shares. One place has been allotted one board lot of Shares, representing approximately 0.67% of total number of places under the International Placing. This place has been allotted less than 0.01% of the 222,620,000 Offer Shares available under the International Placing after reallocation and less than 0.01% of the Offer Shares under the Global Offering inclusive of the over-allocation of 51,370,000 Shares.

The Directors further confirm that the International Placing has been conducted in compliance with the placing guidelines for equity securities as set out in Appendix 6 to the Listing Rules (the "**Placing Guidelines**") and no Offer Shares under the International Placing placed by or through the Joint Global Coordinators, the Joint Bookrunners, the Joint Lead Managers and the Underwriters under the Global Offering have been placed with any core connected person (as such term is defined in the Listing Rules) of the Company or any connected clients (as defined in paragraph 5(1) of the Placing Guidelines) or persons set out in paragraph 5 of the Placing Guidelines, whether in their own names or through nominees. None of the Offer Shares subscribed by the placees or the public has been financed directly or indirectly by any of the Directors, chief executive of the Company, Controlling Shareholders, substantial Shareholders, or existing shareholders of the Company or any of its subsidiaries or their respective close associates, and none of the placees or the public who has subscribed the Offer Shares is accustomed to taking instructions from any of the Directors, chief executive of the Company, Controlling Shareholders, substantial Shareholders or existing shareholders of the Company or any of its subsidiaries or their respective close associates in relation to the acquisition, disposal, voting or other disposition of Shares registered in his/her/its name or otherwise held by him/her/it. No placee will, individually, be placed with more than 10% of the enlarged issued share capital of the Company immediately after the Global Offering. The Directors confirm that: (i) none of the placees under the International Placing will become a substantial shareholder (as defined in the Listing Rules) of the Company immediately after the Global Offering; (ii) the number of Shares to be held by the public will satisfy the minimum percentage prescribed by Rule 8.08(1)(a) of the Listing Rules; (iii) the three largest public shareholders of the Company do not hold more than 50% of the Shares held in public hands at the time of the Listing in compliance with Rules 8.08(3) and 8.24 of the Listing Rules; and (iv) there will be at least 300 Shareholders at the time of the Listing in compliance with Rule 8.08(2) of the Listing Rules.

OVER-ALLOTMENT OPTION

In connection with the Global Offering, the Company has granted the Over-allotment Option to the International Underwriters exercisable by the Joint Global Coordinator (for themselves and on behalf of the International Underwriters) at any time from the Listing Date until 17 January 2021, being the 30th day after the last date for lodging applications under the Hong Kong Public Offering, to require the Company to issue and allot up to an aggregate of 51,375,000 additional Shares, representing in aggregate 15% of the Shares initially being offered under the Global Offering, at the final Offer Price to cover over-allocations in the International Placing. There has been an over-allocation of 51,370,000 Shares in the International Placing and such over-allocation will be settled using Shares to be borrowed under the Stock Borrowing Agreement between Ruide BVI and the Stabilising Manager. Such borrowed Shares will be covered by exercising the Over-allotment Option in full or in part or by making purchases by the Stabilising Manager (or through its affiliates or any person acting for it) in the secondary market at prices that do not exceed the final Offer Price, or by a combination of these means. In the event the Over-allotment Option is exercised, an announcement will be made on the Company's website at www.ruilizx.com and the Stock Exchange's website at www.hkexnews.hk. As of the date of this announcement, the Over-allotment Option has not been exercised.
